## **Annual General Meeting**

A big thank you to those who attended our Annual General Meeting on Saturday 14th September and BBQ that followed on after. We hope you found it useful and we really appreciated all your inputs, ideas and suggestions. The minutes from the meeting are attached for those who couldn't make it and they will also be displayed on our noticeboard and added to our website/Facebook Group in due course.

In summary, our Chairman Bill Whatley reported successful completion of drainage works and a new mains pipe, eliminating past flood issues. He also announced future plans to separate the toilet water supply, keeping facilities open year-round. Financially, our Treasurer, John O'Connell reported that our allotment is healthy with rents exceeding expectations. Major expenditures included road resurfacing and drainage projects, alongside purchases of new equipment. A lottery grant of £20,000 has allowed for the commencement of our shed roof refurbishment in November. However, reserves will be tight post completion.

Our Membership Secretary, Lesley Adnett advised that only 9 plots are vacant as at the time of the meeting and a waiting list system is now implemented. She went over the Plot Maintenance Letters and what they mean, along with a request for plot numbers to be displayed clearly.


Three proposal were then voted on and approved, the full details of which are in the minutes but in summary:

With effect from 31/12/2024 all plot holders are requested to participate in at least 2 Work Parties per year (out of 8 between March and October). If attendance isn't recorded, then £10 per work party missed will be deducted from their deposits (up to £20) to go towards the maintenance costs for our site. This amount is repayable alongside the standard annual rents the following year. The finer details on the scheme will be sent out in forthcoming newsletters, like jobs that can be done during the week etc.

Your committee can borrow up to £2,000 from the plot holder's deposit account to fund future projects if need be.

Lastly, annual rents will now be subject to an inflation adjustment (CPI).

Various infrastructural improvements are anticipated, and trials for Saturday openings of the tool hire rota will be implemented next year.



The next AGM is scheduled for Saturday, 13th September 2025.

## **Fix my Street!**

The height of the trees that align the perimeter along plots 1-23 was brought up at the AGM and the shadows they cast across these plots. LB Bromley are responsible for these trees and every year we have been sending emails to their tree department (along with most other allotment sites in Bromley with similar issues) which get ignored. To be brutally honest they just don't have the resource or funding to deal with anything accept emergencies.

However, we sent in a report on Fix-My-Street (reference 6478630) which is their preferred way of contacting them about such things and this is the reply: Thank you for your enquiry. No action is to be taken regarding the reported trees, please note that as outlined in our Tree Management Strategy (treemanagement-strategy-2023-to-2027 (bromley.gov.uk) the Council will not prune trees in relation to the following:

• Tree size, where a tree is judged to be overly large.

• Obstruction of view: there are no rights associated with maintaining trees in accordance with maintaining views in British law

• Lack of light: there is no 'Right to light' (or shade) in British law.
